FEDERAL DIRECT LOAN RECIPIENTS

Students must be enrolled in 6 or more credits to receive federal Direct Loan funds for Summer 2024.

If you are enrolled in 6 or more credits for summer, do you want to use federal Direct Loan funds?

- Yes, process my federal Direct Loan(s) for Summer 2024 – You must accept your loan(s) on my.newpaltz.edu.
- No, I do not wish to receive a federal Direct Loan for Summer 2024

- Summer loans are expected to disburse after July 1, 2024. If you drop below 6 credits, you will no longer be eligible to receive your summer loan disbursement.
- Most students who receive Direct Loan funds for summer will see a reduction in their direct loan amounts for future semesters of the 2024-25 academic year, since the yearly allocation will be divided into thirds.

FEDERAL PELL GRANT RECIPIENTS

- All matriculated students who attend the summer term will be automatically considered for a summer Pell Grant payment if they have a Pell-eligible SAI (Student Aid Index), regardless of the number of credits they are enrolled for.
- Pell Grant payments will be pro-rated according to your enrollment level.
- Students may be eligible to receive up to 150 percent of their Pell Grant Scheduled Award for an award year. This provision is called Year-Round Pell because it allows students to receive Pell Grant funds for summer in addition to the fall and spring.
